

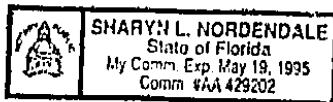




#### ARTICLE XI

#### AMENDMENTS


