Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of JACK F. DURIE, JR., P.A. (the "Corporation"), are hereby amended as follows:

FIRST: Article 1 of the Corporation's Articles of Incorporation is hereby deleted in its entirety, and the following is substituted in lieu thereof:

1. NAME AND PRINCIPAL OFFICE

The name of this Corporation shall be JACK F. DURIE, JR., INC., whose principal office shall be located at 1000 East Robinson Street, Orlando, Florida 32801.

SECOND: This Amendment as filed shall be effective upon ~~execution of the same or, if later, such time and date as is five business days prior to the date on which this Amendment is filed with the Department of State.~~

THIRD: The foregoing Amendment was unanimously adopted pursuant to a Joint Written Action of the Directors and Shareholders of the Corporation Taken Without a Meeting dated as of April 30, 1999, pursuant to Sections 607.0821 and 607.0704, Florida Statutes.
