ARTICLE I

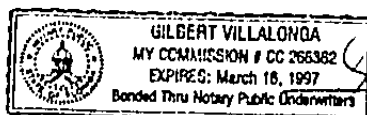

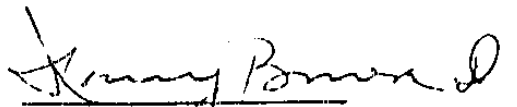

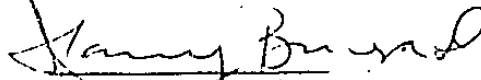
