

ARTICLE I - NAME AND CORPORATE ADDRESS

The name of this corporation is GO-4-U, INC., with its mailing address and principal office located at 4027 Worcestor Road, Sarasota, Florida 34231.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.
