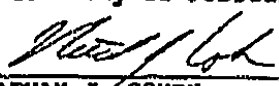
ARTICLE XI. - INTERNAL REVENUE CODE PROVISION

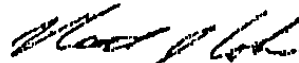
