Dear Ms. Sellers:

As you requested in your letter, this is the explanation for our not filing the Profit Corporation Annual Report in 1996:

On April 28, 1997 our new computer consultant, who is also an accountant, asked if we had a blank copy of the 1997 annual report form. When we told him that we had never heard of such a report, he advised us to call you. Upon calling you, we were advised that our corporation was dissolved in August of 1996 for not filing the annual report. When you asked our mailing address, we learned for the first time that the address shown for The Pot Factory was an Exchange Street address that was used incorrectly. Upon further checking we find that our attorney made the mistake in the original incorporation filing. The information sent by your office to the Exchange Street address in 1996 was apparently never forwarded to us since we were unaware of the mistake on the address and we never received any information from you. Our attorney, who is our Registered Agent is surprised that he did not receive any notification. We have used an accountant from Illinois who was unaware of Florida's filing requirements.
