

ARTICLES OF INCORPORATION

AMERICA A/C SERVICES, INC.

We, the undersigned, do hereby associate ourselves together and subscribe these Articles of Incorporation for the purpose of forming a Corporation under the laws of the State of Florida, Chapter 607 and subject to the following provisions:

ARTICLE ONE:

The name of the Corporation shall be:

AMERICA A/G SERVICES, INC.

ARTICLE TWO:

This Corporation shall have perpetual existence and may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The general nature of the business to be transacted by this Corporation shall be:

- a)- ANY AND ALL LEGAL BUSINESS WITHIN THE STATE.
- b)- To manufacture, purchase or otherwise acquire, and to own, Mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind and description.
- c)- To conduct business in, have one or more offices in, and buy, hold mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchise, patents, copyrights, trademarks, and licenses in the State of Florida, and in all others States, districts, territories, Countries or Colonies.
- d)- To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtness, and execute such mortgage, transfer of Corporate property or other instruments to secure the payment of Corporate indebtness as required

- e)- To purchases the corporate assets of any other Corporation and engage in the same or other character of business.
- f)- To acquire bypurchase, subscription or otherwise and to receive, hold, own guarantee, sell, assign, exchange, underwrite, transfer, mortgage, pledge or otherwise dispose of a deal in and with any of the shares of the Capital Stock or any voting trust certificates in respect of the shares of capital stock, scrip, warrants, rights, bonds, debentures, notes, trust receipts, and other securities, obligations, chose in action and evidence of indebtness or interest issued or created by any Corporation, joint stock companies, syndicates, associations firms, trust, or persons public or private, or by the government of the United State of America, or by any foreign government, c. by any State, territory, province, municipality or other political subdivision or by any government agency, and as owner thereof, to possess and exercise all the rights, powers and privileges of ownership, including the right to execute consents and right to execute consents and vote thereon, and to do any and all acts and things necessary or and for the presentation, protection, improvement, and enhancement in value thereof.

The Corporation shall indemnify and hold harmless each person who shall serve at any time hereafter as a Director or Officer of the Corporation, and any person who serves at the request of this Corporation and a director of Officer of any other Corporation, from and against any and all claims and liabilities to wich such person shall become subject by reason of his having heretofore or hereafter been a director or officer of this Corporation, or by reason if any action alleged to have been heretofore or hereafter taken or amitted by him as such director or officer and shall reimburse such each person for all legal and other expenses reasonably incurred by him in connection with any such claim or liability provide that no person shall be indemnified against, or re reimbursed for, any expenses incurred in connection with any claim or liability as to which it shall be adjudged that such officer or director is liable for negligence or willfull misconduct in the performomance of his duties.


