

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME OF CORPORATION

The name of the corporation is PROFIT TRADING CORPORATION

ARTICLE TWO

PRINCIPAL OFFICE

The principal office of the corporation will be 1450 S. BAYSHORE DR., APT. 2012 MIAMI, FL 33131.

ARTICLE THREE

PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.




CERTIFICATE OF DESIGNATION OF
