

ARTICLES OF INCORPORATION
OF
JESBRIT GROVE SERVICE, INC.

RECORDED

TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is JesBrit Grove Service, Inc..

ARTICLE TWO

The duration of the corporation is to be perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

1. Grove care taking.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is 100 hundred shares. Such shares shall be

of a single class, and shall have a par value of One Dollar and no/100 (\$1.00). All stock issued shall be held of record by not more than ten (10) persons. Stock shall be issued and transferable to natural persons who are not nonresident aliens.

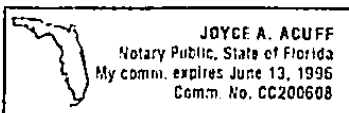
