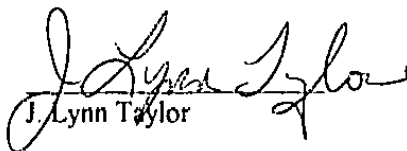

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation.

FIRST: The name of the corporation is:

TAYLOR PHOTO, INC.

SECOND: The period of its duration is Perpetual

THIRD: The purposes for which the corporation is organized are; to operate a facility as a photography service and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 60 shares of common stock having no par value or amount of par value each.

FIFTH: The corporation will not commence business until at least ONE THOUSAND DOLLARS (\$1,000.00) have been received by it as consideration for the issuance of shares.
