

We have received your letter of March 25, 1997. I have enclosed our check for reinstatement in the amount of \$ 375.00. This amount covers the years of 1996 (\$200.00) and 1997 (\$ 175.00). It should be noted that I did not sign point 11 on the form because the corporation did not wish to change our registered agent.
