Gentlemen:

We have received your letter of March 25, 1997. I have enclosed our check for reinstatement in the amount of \$ 375.00. This amount covers the years of 1996 (\$200.00) and 1997 (\$ 175.00). In addition, we have also included a completed corporation document form that was mailed. It should be noted that I did not sign point 11 on the form because the corporation did not wish to change our registered agent.

The reason for requesting reinstatement is that the corporation never received any correspondence about the yearly fees. According to computer printout, the information was mailed directly to our registered agent. Per registered agent, no receipt of this form or correspondence pertaining to Apex Industrial Enterprises is acknowledged by Mr. Phillips. At the Board of Director meeting on April 4, 1997, Mr. Silver was instructed to advise the state to send the yearly renewal form to our post office box address or physical address as opposed to the address of registered agent. In addition, the status of R.A. is to remain status quo.

Trust the action will meet with the approval of the state. We thank you for your cooperation and patience.
