Article I - Name

The name of this corporation is Seacrest Beach Developers, Inc. The initial street address of the principal office and mailing address is P.O. Box 1409, Garfield Street, Santa Rosa Beach, Florida, 32459.

Article II - Duration

This corporation shall exist perpetually, commencing with the date of execution and acknowledgment of these Articles.

Article III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States and Florida.

Article IV - Capital Stock

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

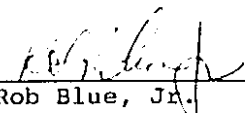
Article X - Preemptive Rights

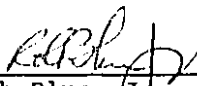
