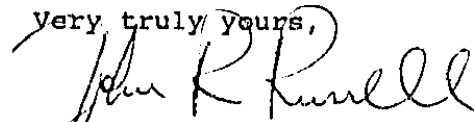

ARTICLES OF INCORPORATION

OF

FLORIDA TSI, INC.

ARTICLE I

NAME

The name of this corporation is Florida TSI, Inc.

ARTICLE II

PURPOSE

This corporation is organized for the purpose of selling, remanufacturing and servicing laser toner cartridges and transacting any and all other lawful business authorized by the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue one hundred shares of \$.10 par value common stock.

ARTICLE IV

PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

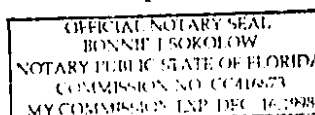
