ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of V-TECH SALES & SERVICE, INC., under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE I - NAME


RTICLE IX - BYLAWS
