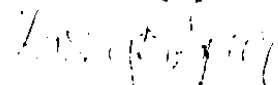

The undersigned hereby subscribes to these Articles of Incorporation and executes same for the purpose of becoming a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the Corporation shall be SPEER PALM TREES, INC.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the filing of these Articles with the Secretary of State of the State of Florida.

ARTICLE III - PRINCIPAL OFFICE

The principal office of the corporation is 2415 Timothy Court, Mims, Florida 32754. The mailing address for the corporation is Post Office Box 859, Mims, Florida 32754.

ARTICLE IV - PURPOSE
