ARTICLES OF INCORPORATION OF

A.S.A.P. CARPET CLEANING, INC.

The undersigned Subscriber, a natural person competent to contract, desires to form a Corporation under the laws of the State of Florida, and hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of the Corporation is A.S.A.P. CARPET CLEANING, INC., and the principal office and address is: 6536-7 Beach Boulevard, Jacksonville, FL, 32216.

ARTICLE II. NATURE OF BUSINESS
