ARTICLES OF INCORPORATION OF CAPLAN & ASSOCIATES, C.P.A.18, P.A.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the Business Corporations Act and other laws of the State of Florida.

ARTICLE_I

The name of the corporation is Caplan & Associates. C.P.A.

ARTICLE II
