ARTICLE I - NAME

The name of this corporation is R.W. GRIFFITHS CORPORATION

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing these Articles of Incorporation with the Department of State of the State of Florida.

ARTICLE III - PURPOSE
