ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms and organizes a corporation for profit under the laws of the State of Florida

ARTICLE I - NAME

The name of the corporation is Cliftons' Country Enterprises, Inc. and the address of the corporation is Rix 1 Box 391 Branford, Fl. 32008

ARTICLE II - DURATION AND COMMENCEMENT OF EXISTENCE

This corporation shall have perpetual existence. The corporation shall commence existence at 12.01 P.M. on February 6, 1995

ARTICLE III - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any time is 1000 shares of common stock, having a par value of \$.01 per share, fully paid and non-assessable.

Authorized capital stock may be paid for in cash, services, or property, at a just value, but not less than par value, to be fixed by the Board of Directors of this corporation.

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase this prorated share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V - REGISTERED OFFICE AND AGENT
