

ARTICLES OF INCORPORATION OF
A-1 DISTRIBUTORS, INC.

ARTICLE I.

CORPORATE NAME

The name of this corporation shall be: A-1 Distributors,
Inc.

ARTICLE II.

NATURE OF CORPORATE BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
