

## ARTICLES OF INCORPORATION

#### OF

## G-E-K PAINTING, INC.



#### Article I.

The name of this corporation is G-E-K PAINTING, INC. and the mailing address of the corporation shall be 2222 Second Street, Fort Myers, FL 33901.
