The undersigned subscriber to these Articles of theorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be ZAIPEC, INC. The principal place of business shall be as follows:

ARTICLE II - DURATION .

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.
