Article I

Name: The name of this corporation is W. W. Scott Communications, Inc.

Article II

Principal Office: The principal place of business and mailing address of this corporation shall be: 1325 NE 9th Street, Gainesville, FL 32601.

Article III

Duration: The period of duration of this corporation shall be perpetual, commencing on the date of execution and acknowledgement of these articles.

Article VIII


By Laws: The corporation shall have one (1) Director initially. The number of Directors may be increased or decreased from time to time by the By-Laws, but it shall

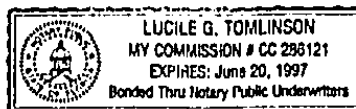
