

ARTICLES OF INCORPORATION

OP

Article I - Name

The name of the corporation is BIEGER & ASSOCIATES, INC. and the principal office and mailing address is 1540 Gulf Boulevard, Clearwater, Florida 34630.

Article II - Duration

This corporation shall exist perpetually.
