ARTICLES OF INCORPORATION

OF

SSFEB IS MIDISI The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME AND ADDRESS

The name of the corporation is McKeever Reporting, Inc. The principal office and mailing address of the corporation is 1662 Park Terrace, West, Atlantic Beach, Florida 32233.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are the following:

- To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

AMENDMENT

No stockholder shall do any act (including the sale or transfer of such stockholders stock) which shall contravene or revoke the corporation's election to be taxed as an "S" corporation.

COMMENCEMENT OF CORPORATE EXISTENCE
