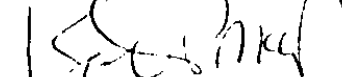

ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME AND ADDRESS

The name of the corporation is McKeever Reporting, Inc. The principal office and mailing address of the corporation is 1662 Park Terrace, West, Atlantic Beach, Florida 32233.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable

In order to accomplish them.

ARTICLE IV

SHARES

The aggregate number of shares which the corporation is authorized to issue is five hundred (500) shares of common stock. Such shares shall be of a single class and shall have par value of \$1.00 per share.

ARTICLE VI

INITIAL BOARD OF DIRECTORS

The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the By-Laws, but shall never be less than one (1). ARTICLE VIII

AMENDMENT

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE IX

RESTRICTIONS AGAINST VIOLATION OF "S" STATUS

When the corporation shall elect to be taxed as an "S" corporation under the Internal Revenue Code, the corporation shall only authorize and issue one class of stock (voting or non-voting). No stockholder shall do any act (including the sale or transfer of such stockholders stock) which shall contravene or revoke the corporation's election to be taxed as an "S" corporation.

ARTICLE X

COMMENCEMENT OF CORPORATE EXISTENCE

In accordance with §607.0203, Florida Statutes, the date when corporate existence shall commence is March 1, 1995, or the date of subscription and acknowledgement of these Articles of Incorporation, whichever is later.
