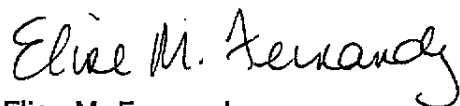
I know that an individual was using it prior to my request and I sent him an affidavit for him to sign to request the name change and, unfortunately, have not heard any response from him.
