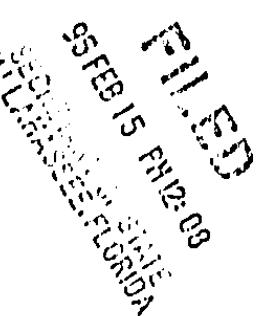

for the purpose of becoming a corporation under the laws of
the State of Florida, by and under the provisions of the
