#### ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation  $\Lambda$ ct, hereby adopts the following  $\Lambda$ rticles of Incorporation.

#### ARTICLE I

The name of the corporation shall be J & S TRAVEL, INC..
