## ARTICLES OF INCORPORATION OF PREMIER CLEANERS, INC.

SECRETE IN 1:50

I, the undersigned, for the purposes of forming a corporation under the Florida's General Corporation Act, Chapter 607, Florida Statutes, do hereby adopt the following articles of incorporation:

#### **ARTICLE I**

The name of the corporation is PREMIER CLEANERS, INC.

#### **ARTICLE II**

The duration of the corporation is perpetual.

#### **ARTICLE III**

The general purposes for which the corporation is organized are:

- 1. 
