ARTICLES OF INCORPORATION

INTERNATIONAL INQUIRY CORPORATION

THE UNDERSIGNED, subscriber to these Articles of Incorporation, natural person competent to contract, hereby presents these Articles for the formation of a corporation under the provisions of Chapter 607 Florida State Statutes, also known as the Professional Service Corporation Act, and other laws of the State of Florida.

ARTICLE I- NAME

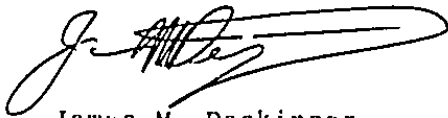
