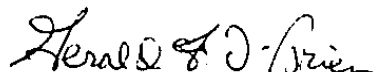

ARTICLE OF INCORPORATION

OF

GULF COAST PHYSICIANS HEALTHCARE NETWORK, INC.

The undersigned (the "Incorporator") organizes a corporation under the Florida Business Corporation Act, and pursuant to the following Articles of Incorporation:

ARTICLE I

The name of this corporation is Gulf Coast Physicians Healthcare Network, Inc. (the "Corporation").

ARTICLE II

The street address of the initial principal office of the Corporation is: 2540 S. Tamiami Trail, Sarasota, Florida 34239.

ARTICLE III

The purpose of this Corporation is to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, including the organization of physicians for the purpose of developing a medical provider network and the identification, negotiation and management of contracts between the provider network and health insurers and/or managed care organizations.
