

ARTICLES OF INCORPORATION
OF
SOUTHERN CONSTRUCTION SERVICES, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

Article I

The name of the corporation is SOUTHERN CONSTRUCTION SERVICES, INC.

Article II

This corporation shall have perpetual existence, except that the same may be dissolved as provided by law.

Article III

The general purpose(s) for which the corporation is organized are:

1. To be designated as a duly authorized general contractor pursuant to Florida law and the licensing criteria of the Florida Construction Industry Licensing Board, and to engage in the business of construction as a general contractor.
2. To carry on any business, occupation, undertaking or enterprise and to exercise any power of authority which may be done by a for-profit corporation organized and existing under and by virtue of Florida Statutes, it being the intention that this corporation may conduct and transact any business lawfully authorized and not prohibited thereby; and
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

Article IV

The aggregate number of shares which the corporation is authorized to issue is 1,000. Such shares shall be of a single class and shall have a par value of One and 00/100 (\$1.00) Dollar per share.

Article V
