ARTICLES OF INCORPORATION OF STANDARD BLECTRIC, INC.

The undersigned, for the purposes of forming a corporation under the Florida Corporation Act hereby adopts the foliowing, or Articles of Incorporation:

ARTICLE ONE

The name of the corporation is Standard Electric, Inc.

ARTICLE TWO DURATION

The term of existence of the corporation is perpetual.


