ARTICLES OF INCORPORATION
OF
STANDARD ELECTRIC, INC.

The undersigned, for the purposes of forming a corporation under the Florida Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation is Standard Electric, Inc.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSE

The general purposes for which the corporation is organized are the wholesale and retail sales, installation and servicing of electrical and contracting equipment and to transact any other lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE FOUR
CAPITAL STOCK

The maximum number of shares which the corporation has authority to issue is 100, all of which shall be common shares with a par value of \$1.00 each.

ARTICLE FIVE
REGISTERED OFFICE

ARTICLE SIX
DIRECTORS

The Board of Directors of the corporation shall consist of not more than three (3) members. The method of election of directors shall be as stated in the By-Laws.

The Articles of Incorporation may be amended from time to time by resolution of the Board of Directors or by meeting of the shareholders pursuant to the procedures for amendment established under the Florida General Business Corporation Act. The procedural formalities may be dispensed with upon the written consent of all shareholders and all directors.
