### ARTICLES OF INCORPORATION

#### ARTICLE I. NAME

The name of this corporation is SOUTHERN THUNDER AMERICAN MOTORCYCLES, INC.

### ARTICLE II. DURATION

The period of duration of this corporation is perpetual.
