ARTICLES OF INCORPORATION of MARY A. MARNEJ.L, P.A.

The undersigned, acting as sole incorporator, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I Name and Principal Office

The name of the corporation shall be Mary A. Marnell, P.A.. The address of the principal office of the corporation is 5551 Ridgewood Drive, Suite 201, Naples, FL 33963.
