ARTICLE I
NAME

DURATION

This corporation shall have perpetual existence and these Articles are effective upon signing.

ARTICLE III

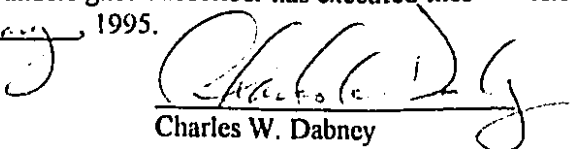
ARTICLE IX INDEMNIFICATION
