ARTICLES OF INCORPORATION

OF

AMERICAN PAD-EX OF FLORIDA, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is AMERICAN PAD-EX OF FLORIDA, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the corporation is 22009 U. S. 19 North, Clearwater, FL 34625, and the mailing address of the corporation is P. O. Box 6122, Palm Harbor, FL 34684-0722.

ARTICLE III - DURATION

The duration of the corporation is in perpetuity.

ARTICLE IV - PURPOSE

The general purposes for which the corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

ARTICLE V - CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have \$1.00 par value.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 22009 U. S. 19 North, Clearwater, FL 34625, and the name of its initial registered agent at that address is JIM S. CORLEY, JR.

ARTICLE VII - THE INITIAL BOARD OF DIRECTORS

The number of directors constituting the initial board of directors is one. The number of directors may be increased or decreased from time to time in accordance with the by-laws, but shall never be less than one. The name and address of the initial director of the corporation is:


