**Articles of Incorporation
of

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

Article I - Name

The name of this corporation is **DeTra Corporation**.
At 9 Spencer Shores, Haines City, FL 33844

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

The purpose for which this corporation is organized is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

Article IV - Capital Stock

The aggregate number of shares that the corporation shall have the authority to issue is 10,000 shares of common stock with a par value of \$1.00 per share.

Article V - Preemptive Rights

The shareholders of the corporation shall have preemptive rights to the corporation's common stock.

Article VI - Initial Registered Office and Agent

The address of its initial registered office is 9 Spencer Shores, Haines City, Florida 33844, and the name of its initial

registered agent at said address is LAWRENCE A. WATERS.

Article VII - Initial Board of Directors
