ARTICLE I - NAME AND MAILING ADDRESS

The name of this corporation is JAMES RUGGIERO, INC. and the mailing address of this corporation is 3625 Simcoe Court, Palm Harbor, Florida 34684.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized to include the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes (1975) as presently enacted and as it may be amended from time to time.

ARTICLE IV - CAPITAL STOCK


ARTICLE VIII - INDEMNIFICATION


