ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

MARINE BANK OF THE FLORIDA KEYS

PURSUANT TO the provisions of Section 607.1006, Florida Statutes, this Florida corporation adopts the following articles of amendment to its Articles of Incorporation:

Article III, entitled "CAPITAL STOCK", is hereby deleted and the following Article III, entitled "CAPITAL STOCK" is hereby substituted in its place:

ARTICLE III CAPITAL STOCK

The total number of shares authorized to be issued by the corporation shall be 1,000,000 common shares. Such shares shall be of a single class and shall have a par value of \$5.00 per share.

The date of this Amendment was 26 April 1997.
