ARTICLES OF INCORPORATION OF DANIEL ETTEDGUI, D.O., P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a professional association under the laws of the State of Florida.

ARTICLE I - NAME:

The name of the professional association shall be DANIEL ETPEDGUI, D.O., P.A.

ARTICLE II - ADDRESS:

The principal mailing address and principal address of the professional association shall be 7505 London Lane, Boca Raton, PL 33433.

ARTICLE III - PURPOSES

The purposes for which the professional association is formed and the business and objects to be carried on and promoted by it is the practice of Physiatric Medicine and any and all lawful acts that can be performed by a Florida professional association.

Any action by the directors of this Professional association which is within their power taken at a meeting of such directors shall be valid for all intents and purposes whether or not lawful actice of said meeting shall have been given to all directors as required by law or by the By-Laws of this Professional association, if at any time prior to, during or after such meeting, all directors shall execute a waiver of notice of such meeting, in writing, and providing a majority of the directors shall have approved or approve the action taken at such meeting.

When not prohibited by law, any action by the shareholders of this Professional association which is within their power taken at a meeting of such shareholders shall be valid for all intents and purposes whether or not lawful notice of said meeting shall have been given to all shareholders, as required by law or the By-Laws of this Professional association, if at any time prior to, during or after such meeting all shareholders shall execute a waiver of notice of such meeting in writing and providing a majority of the shareholders shall have approved or approve the action taken at such meeting.

When not prohibited by law, any action of the shareholders of this Professional association may be taken without a meeting if consent in writing, setting forth the action so taken, shall be signed by all the persons who would be entitled to vote upon such action at a meeting and filed with the Secretary of the Professional association as part of the corporate records. Such consent shall have the same force and effect as the unanimous vote of the shareholders and may be stated as such in any certificate or document filed with the Department of State of the State of Florida or any other governmental agency of any state, county or nation, or with any private organization, corporation, person or persons.

Nothing in this Article shall be construed to allow any act of the Board of Directors to be approved by less than a majority of said directors, or wherever a greater vote is required by law or in the By-Laws for that vote.

Members of the Board of Directors or of any executive committee designated by the Board of Directors in accordance with law shall be deemed present at any meeting of the Board of Directors or executive committee, as the case may be, if a conference telephone or similar communications equipment by means of which all persons participating in the meeting can hear and be heard by all other persons, is used.

ARTICLE XIII - SHAREHOLDER'S AGREEMENT


