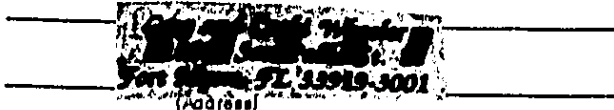

ARTICLES OF INCORPORATION
OF

ARTICLE I.

The name of this corporation is: Quality Crafted Homes, Inc.

The principal address is: 10060 San Pablo
Fort Myers, Florida 33919

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in building construction as permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of share of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock with a par value of \$1 (one dollar) per share.

ARTICLE IV. TERM OF EXISTENCE

This Corporation shall have a perpetual existence commencing upon issuance of the certificate of incorporation from the Secretary of State.

ARTICLE IX. AMENDMENT

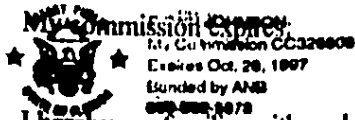
