The Undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is: Taylor Financial Services Group, Inc. The principal office and mailing address is 3938 Sunbeam Road, Suite 2, Jacksonville, Florida, 32257.

ARTICLE 2.0 DURATION

The duration of the Corporation is perpetual.

ARTICLE 3.0 PURPOSE
