ARTICLES OF INCORPORATION
OF

ARTICLE 1 - CORPORATE NAME

The name of the corporation shall be

ARTICLE 2 - NATURE & POWERS

The general nature of the business to be transacted by this corporation is to engage in providing real property remodelling and painting services.

ARTICLE 3 - CAPITAL STOCK

The maximum number of shares this corporation is authorized to issue and have outstanding at any one time is 7500 shares of common stock at \$1.00 par value.

ARTICLE 4 - TERM OF EXISTENCE

This corporation shall have perpetual existence, commencing upon acceptance by the Secretary of State of these articles.
