ARTICLES OF INCORPORATION

Article I - Name

The name of this corporation is SBD South, Inc. The initial street address of the principal office is 8281 East Hwy. 30A, Panama City Beach, Florida, 32413 and the mailing address is P.O. Box 2096, Santa Rosa Beach, Florida, 32459.

Article II - Duration

This corporation shall exist perpetually, commencing with the date of execution and acknowledgment of these Articles.

Article III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States and Florida.

Article IV - Capital Stock

This corporation is authorized to issue 7500 shares of One Dollar (\$1.00) par value common stock.

Article V - Initial Registered Office and Agent

Article VIII - By-Laws
