ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is Infofax Communications, Inc.

ARTICLE TWO

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is February 13, 1995.

ARTICLE THREE

The general purposes for which the corporation is organized are:

1. To engage in the business of providing remote data and voice storage/retrieval products and services.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is 10,000. Such shares shall be of a single class and shall have a par value of Ten Cents (\$0.10) per share.

ARTICLE FIVE

The street address of the initial registered office of the corporation is 12306 Autumnbrook Trail West, Jacksonville Florida 32258 and the name of its initial registered agent at such address, is William S. Smith. The registered office will also be the corporations's principal office.

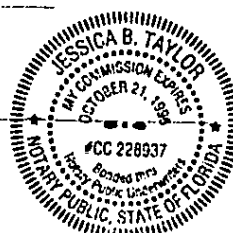
