I, the undersigned, in order to form a Corporation under and pursuant to the provisions of the Laws of the State of Florida for the purposes set forth below, do hereby subscribe to these Articles of Incorporation.

ARTICLE I.

The name of the Corporation shall be CUCUMBERS, EARTH FRIENDLY FAST FOOD, INC.

ARTICLE II

The purposes and general nature of the business to be transacted and conducted by the Corporation shall be to engage in the fast food restaurant business and to do and transact any and all business as permitted under the laws of the State of Florida and the United States of America.

Without limiting any of the purposes, powers and objects of this Corporation, it is expressly declared and provided that this Corporation shall have power in carrying on its own business, or for the purpose of accomplishment of any of the purposes or attainment of the objects hereinabove specified, to make and perform contracts of any kind and description and to do any and all other acts and things and to exercise any and all powers, either as principal, agent or broker, conferred by the laws of Florida upon Corporations, and which a partnership or natural person could exercise, and which now or hereafter may be authorized by law.

ARTICLE III.

The number of shares of stock that this Corporation is authorized to have outstanding at any time is one thousand (1000) share of ten (.10) cents par value.

ARTICLE IV.

The amount of capital with which this Corporation shall begin business shall be One Hundred (\$100.00) Dollars.

ARTICLE V.

The existence of this Corporation shall be perpetual.

ARTICLE VI.

The principal office of this Corporation shall be located at 11866 Winged Foot Terrace, Coral Springs, Florida 33071, County of Broward, State of Florida.

ARTICLE VII.

The number of Directors of the Corporation shall be one (1). The number of Directors may be increased from time to time in a manner set forth by the By-laws adopted by the Stockholders but shall never be less than one.
